JUSTIFICATION AND APPROVAL FOR OTHER THAN FULL AND OPEN COMPETITION

1. **CONTRACTING OFFICE**: Defense

- 2. TYPE OF CONTRACT ACTION: The type of action contemplated is a continuation of utility services due to privatization of natural gas and electrical services on the installation. Contract will be through the GSA areawide public utility contract GSA GS-00P-06-BSD-0399 with Colorado Springs Utility, a municipal utility. Contract is anticipated to be fixed price contract, as determined by rates established under the Department of Regulatory Agencies, Public Utilities Commission for the State of Colorado, and indefinite quantity, which will fluctuate depending on actual usage. Electric and natural gas rates are listed under the Rate Schedules for Contract Service for the USAF Academy on the Colorado Springs Utilities' website. This effort will utilize DWCF funding.
- **3. DESCRIPTION OF SUPPLIES/SERVICES:** The USAF Academy Commissary currently uses electrical and natural gas services. Estimated cost for the base year award for electrical services is \$177,000 for a 12-month base period. The base year, two one-year and one ninemonth option periods estimated total for electrical services will be \$663,750. Estimated cost for the base year award for natural gas services is \$21,000 for a 12-month base period. The base year, two one-year and one nine-month option periods estimated total for natural gas services is \$78,750. Total for base period for both services is \$198,000, for the base and two one-year, and one nine-month option periods \$742,500. The last option runs through May 29, 2016, as the current GSA contract expires after that date.
- **4. AUTHORITY CITED:** Statutory Authority 10 U.S.C. 2304 (c) (1), as implemented by FAR 6.302-1, Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements.
- **5. REASON FOR AUTHORITY CITED:** The Colorado Public Utilities Commission regulates electrical and natural gas distribution companies for the State of Colorado. The USAF Academy is under the Colorado Springs Utilities municipal area.
- 6. EFFORTS TO OBTAIN COMPETITION: Market research was conducted and indicated that there are no other electrical or natural gas providers in the USAF Academy area who can supply electricity and natural gas to the USAF Academy Commissary. FAR 41.204(c) "GSA Areawide Contracts Procedures for obtaining service", states that the any Federal agency "...shall acquire services under the areawide contract unless" there is more than one supplier or if no advantage is provided to the agency by using the GSA contract. For this action neither exception applies, as there is no competition available to this municipal utility company. A

synopsis will not be posted to FedBizOpps as the exception under FAR 5.202(a)(5), utility services and only one source available applies.

- 7. FAIR AND REASONABLE COST DETERMINATION: As stated in Paragraph 2, rates are regulated by the State of Colorado by the Colorado Public Utilities Commission.
- **8. MARKET RESEARCH:** Per internet search, the Colorado Public Utilities Commission website provided one electrical services and natural gas provider in the USAF Academy Commissary area, Colorado Springs Utilities. The company is the sole utility provider for electrical and natural gas service of this nature at the installation and they have a GSA areawide public utility contract for these services.
- **9. OTHER FACTORS:** There are no previous contracts awarded for this service at this commissary location, as DeCA reimbursed the installation for the commissary utility costs in the past. The installation has now privatized the electric and natural gas services to Colorado Springs Utilities.
- **10. INTERESTED SOURCES:** To date, Colorado Springs Utilities is the only available source capable of providing this specific service at the USAF Academy. To date, no other sources have expressed an interest in writing.
- 11. ACTION TO INCREASE/FOSTER COMPETITION: As stated under Paragraphs 5 and 6, Colorado Springs Utilities own the lines and are under a GSA areawide public utility contract, no actions are available to increase/foster competition.
