Products listed on this J&A are subject to the agency's current VOIP platform migration succeeding which is currently in the implementation phase. Should alternate product be required without substantial change or cost, this J&A serves to authorize that upgrade. Estimated delivery is June 1, 2013 contingent upon a successful deployment of the VOIP upgrade. Maintenance period of performance is one year from date of award through 12-months.

4. IDENTIFICATION OF STATUTORY AUTHORITY: 10 U.S.C. 2304(c)(1) as implemented by FAR 6.302-1(c). Application of Brand Name Descriptions

5. IDENTIFICATION OF JUSTIFICATION RATIONALE:

Cisco brand name hardware and software products are requested to maintain uniformity to ensure consistency in the design, and minimize compatibility issues. DeCA is currently operating a Cisco network protocol which utilizes Cisco software and hardware bundles. Other than Cisco brand software and hardware bundles have previously been bought and tested and the agency encountered systemic compatibility issues. Had the agency not maintained a number of spare parts allowing for expeditious replacement, an indeterminate amount of down time could have occurred. This particular technical refresh for the agency's VoIP test bed is critical as it is the baseline for all upgrades, fixes, and releases critical to maintaining a healthy VoIP system. A test-bed environment allows agencies to test changes prior to implementation to ensure issues that arise are resolved before full deployment occurs. Without a fully functional test-bed environment that is updated to mirror the current software and hardware bundles configuration, currently utilized by DeCA would preclude the agency's ability to perform, critical, functional testing thus leaving the agency vulnerable to information assurance risks.

In continuing to maintain a Cisco VoIP system at DeCA HQ, interconnectivity can be maintained with Cisco VoIP networks in use at all three area data centers and DeCA's 240 commissary store's CME8 Cisco systems. Cisco VoIP technology for infrastructure and phones are currently in place at DeCA HQ as part of a Department of Defense (DoD) mandate to utilize

voice over internet protocol technology. Phone system failure could potentially affect the agency's ability to provide the service member, spouses, retirees and dependents with support necessary to maintain a fully functional commissary operation. A recent outage precluded patrons from being able to contact their support store and the implications of that cannot be expressed in general terms.

6. DETERMINATION OF FAIR AND REASONABLE COST:

In accordance with FAR parts 8.404, 12.209, 13.106-1(2), and 14.408-2, I hereby determine that the anticipated cost or price to the Government for this contract action will be fair and reasonable. The price reasonableness memorandum detailing the Fair and Reasonable Price Determination will be included in the contract file documentation.

7. MARKET RESEARCH:

Market research was conducted utilizing the system for award management's Central Contractor Registration (CCR) site, the ARMY CHESS ESI (CHESS), NASA SEWP IV (SEWP), and GSA Advantage sites. This research indicates that there are numerous sources available that offer pricing through these contractual vehicles. However, some Cisco partners and resellers available through the SEWP contractual vehicle, an existing Government Wide Acquisition Contract (GWAC), are gold or premier partners who have an advantage over other Cisco resellers as they are generally able to offer an additional discount above the already discounted SEWP contract prices. Additionally, DeCA has successfully solicited and awarded competitive CISCO acquisition buys through SEWP IV contract vehicles.

8. ANY OTHER SUPPORTING FACTS:

DeCA has been utilizing the VoIP system since November 2008. This acquisition will serve to perform a technical refresh of the existing VoIP test bed infrastructure to include software and hardware upgrades. The use of VoIP as mandated by the DoD's Defense Information Systems Agency (DISA) requires that VOIP solutions be approved by the Joint Interoperability Test Center (JITC) and there are only a limited number of systems which meet this criterion. Cisco's VoIP solution is one of the approved systems by DISA/JITC to operate on the DoD network. Therefore, maintaining a VoIP system already approved by JITC is in the best interest of the Government versus having to go through the testing/approval and subsequent certification processes. Performing a technical refresh of our Unified Communications system from version Call Manager 4.3 to Unified Call Manager 8.6 has already been approved by the JITC program office.

9. ACTIONS TAKEN TO REMOVE BARRIERS TO COMPETITION:

DeCA will continue to perform the necessary market research for its information technology telecommunications requirements; however, DoD policy has established that for this type of commodity, unless the product(s) are JITC approved, competition is limited at best. While this requirement is limited to companies that are able to provide brand name Cisco software and hardware; market research has identified numerous resellers to include small business concerns through varying contractual vehicles that have the capability to fulfill this requirement; therefore, there is a high expectation that the agency will receive adequate competition for this requirement.
