5. IDENTIFICATION OF JUSTIFICATION RATIONALE:

The Defense Commissary Agency (DeCA) manages commissary operations worldwide for the Defense Department. This includes the Headquarters, region offices, and approximately 250 commissaries worldwide. The Customer Support Services Branch under the Information Technology (IT), Technology Enhancement Division, needs to purchase additional CALs for the Good server for the Bring Your Own Device (BYOD) pilot. IT is currently testing a limited pilot of BYOD. This pilot will initially test the mobile platform from the Android OS to the iOS devices (phones and tablets). Good is the only manufacturer that provides the products as described in paragraph 3. This BYOD pilot has just started and works in conjunction with mobile devices for the agency head and senior executives. DeCA currently has five (5) licenses in place. These products do not impact any other applications in the agency.
