Contractor shall provide all costs associated with travel from the contractors hub to Great Lakes,IL, loading of truck, travel to Fort McCoy, WI, unloading of truck and all costs associated with the return trip and delivery of items to Great Lakes from Fort McCoy, WI, and returning to hub in accordance with the Statement of Work 3 days per week.

Cost per trip: \$930.00 x 156 = Total Line Item Cost \$145,080.00
(156 = 3/week X 52 weeks)

Provide the following information for purpose of calculating fuel adjustments:

Number of Miles per Round Trip: 555 miles

Number of Gallons per Round Trip: 70 gal

Fuel Price Adjustments will be authorized once every six months based on the average price of diesel fuel per gallon for the previous six month period.

Adjustments may be made up or down when the difference exceeds 10%.

Full History spreadsheet (Monthly Diesel All Types) will be used to determine the average for the previous six months. Adjustments will be made each December and June. Type: Midwest No. 2 diesel retail Prices Monthly History.

Current fuel base line rate as of 4/29/13 is \$3.839 per gallon. This will be the baseline cost per gallon. Once an adjustment is made, that average cost per gallon will become the new baseline.

The price adjustment will be incorporated in the quoted cost per trip.

EXAMPLE: Baseline price per gallon: \$3.839 - New Avg price per gallon: \$4.385
(4.385 - 3.839 = .546 X 75 (gallons per trip) = \$40.95 Increase per trip).
