- **4. IDENTIFICATION OF STATUTORY AUTHORITY**. 10 U.S.C. 2304(c)(1), FAR parts 6.302-1 (a)(iii) and (b)(2) Follow-on contract action and the existence of limited rights in data, patent rights, and copyrights and 8.405-6(b)(1), Limited Sources Justification, only one source and no other supplies or services will satisfy agency requirements.
- **5. DEMONSTRATION OF CONTRACTOR'S UNIQUE QUALIFICATIONS.** DeCA Office of the Inspector General (IG) has been utilizing the Entellitrak software applications since October 2011and the issuance of a fixed price delivery order is a logical follow-on to the original order.

The previous acquisition was issued as a firm fixed price delivery order (order) to Micropact under the GSA 8(a) STARS I program. However, in May of 2014 Micropact contacted the Contracting Officer (KO) advising that their company had graduated from the GSA 8(a) STARS program and their schedule would expire on May 31, 2014. DeCA's KO contacted the GSA KO (Mr. Howard Innis) requesting that the agency's order be allowed to run to term, ending September 27, 2014. Mr. Innis advised that the request must be submitted in writing and advised that they were granting waivers in some instances to allow for this. This same date the DeCA KO submitted an email request to Mr. Innis requested the stay on the order. On May 15, Mr. Howard Innis responded affirmatively to the DeCA request and allowed the order to run its course. He further advised that no additional options would be honored.

DeCA's IG office has a continued need for the maintenance support which provides software updates, patches, fixes and the like to ensure that the software application remains compliant with existing Department of Defense (DoD) and Defense Information Systems Agency security technical configuration guidelines (STIG) for use on the DoD and agency networks enterprise to preclude any risk to the DoD or agency enterprise.

Micropact is the sole entity permitted to license and provide maintenance support for the Entellitrak software application. This has been provided through written communication by the manufacturer, Micropact.

- **6. FEDBIZOPPS ANNOUNCEMENT/POTENTIAL SOURCES:** In accordance with FAR Part 5.202(a) 11 and 13(i), this requirement will be posted with the issuance of the solicitation on the respective contracting agency's website.
- 7. Determination by the ordering activity Contracting Officer that the anticipated order represents the best value consistent with 8.404(d). In accordance with FAR 8.404, 12.209, 13.106-1(2), and 14.408-2, I hereby determine that the anticipated cost or price to the Government for this contract action will be fair and reasonable. The price reasonableness memorandum detailing the Fair and Reasonable Price Determination will be included the contract file documentation.
- **8.** MARKET RESEARCH. In accordance with FAR part 6.302-1(iii) due to the proprietary nature of the software and the letter provided from the manufacturer stating that they have no authorized resellers for providing either their software products or its support, market research was not conducted for this acquisition.
- 9. ANY OTHER SUPPORTING FACTS. Due to the DoD's standardization mandate for its enterprise architecture to include IT applications/ products, the agency wishes to maintain the use of its commercial off the shelf (COTS) product for use of its data tracking. This will ensure no disruption to the agency's support and our requirement to meet the President's Council for Integrity and Efficiency's Quality Standards for Investigations (PCIE) to "store investigative data in a manner allowing effective retrieval, referencing and analysis".
- 10. ACTIONS TAKEN TO REMOVE BARRIERS TO COMPETITION. DeCA continues to perform market research for products that are available and designed to run on open platforms and through virtualization in lieu of the old legacy closed platform applications. DeCA communicates and works with other DoD agencies, its business partners, and attends trade and industry shows, in an effort to stay abreast of this evolving technology. As legislation and regulatory changes mandated by DoD change and influence the DoD department's information technology requirements, the commercial market place's ability to stay abreast of those changes and provide viable solutions will also change.
