SUBJECT: Update! Web Pricing and EBS Vendor Portal

The purpose of this notice is to advise Industry that after **November 30, 2017**, vendors will no longer be able to submit list costs in DeCA's Web Pricing System. Instead, vendors must use DeCA's EBS Vendor Portal to submit costs and adjustments.

Vendors submitting weekly costs must use Vendor Portal beginning December 5, 2017.

Vendor Portal is fully operational, and DeCA thanks the vendors who are using the portal to submit their costs and adjustments. If you have not yet registered for Vendor Portal, complete the worksheet attached to this notice and email it to **signup@deca.mil**. DO NOT DELAY!
