# What you need to know about CREDIT CARD/DEBIT CARD USER FEES

### 1.9% for Credit and Signature Debit Cards

► The fees will be assessed at 1.9% of the total transaction cost to these new patrons who use credit cards and signature debit cards, which are accepted and processed as credit transactions.

#### 0.5% for PIN Debit Cards

➤ The assessed fee will be 0.5% for personal identification number (PIN) debit card transactions.

### **User Fee Exemptions**

▶ Individuals paying cash and using the MILITARY STAR card, Supplemental Nutrition Assistance Program (SNAP) Electronic Benefits Transfer (EBT) and eWIC cards will not be assessed the user fee on their transactions.

The John S. McCain National Defense Authorization Act of Fiscal Year 2019 expanded commissary shopping patronage to certain veterans and veteran caregivers effective January 1, 2020.
