(2) While not required, the contractor MAY include in its subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.

As requested by a DeCA Contracting Officer or a DeCA Transportation Specialist, the contractor shall fumigate crates delivered by the Defense Commissary Agency (DeCA) vendors that are not in compliance with the Nematode treatment requirements or similar treatment requirements. The contractor shall provide replacement treated pallets for those pallets delivered by DeCA vendors that are not in compliance with the Nematode treatment requirements of the receiving countries.

PICKUP AND DELIVERY SCHEDULE: The Contractor, upon receiving items from the vendor/supplier's carrier shall:

- a. *Manifest* in the Electronic Shipper System (ESS) the boxes/cases received in the next available resale subsistence container.
- b. Provide truck load sheet and Page information to include destination, requisition number, number of boxes or pallets, weight and cube to DeCA Transportation Office prior to container departure.
- c. Ensure that there is no visible damage to the boxes/cases received.
- d. Inspect the number of boxes/cases received and NOT the contents of the boxes/cases.
- e. Ensure the number of boxes/cases received matches the number of boxes/cases shown on the packing slip/bill of lading.

- f. If the boxes/cases exceed the capacity of the resale subsistence containers or unforeseen delays arise, the contractor will contact DeCA Transportation Office.

Performance will include one (1) base year and four (4) options years subject to FAR Clause 52.217-9, "Option to Extend the Term of the Contract."

The Contractor shall have thirty (30) days after the end of the contract performance period to complete all supply and equipment shipments.
