NOTICE TO THE TRADE – DeCA NOTICE 21-105

SUBJECT: MDV Bloomington Item Assortment

The purpose of this notice is to provide an update on DeCA's efforts to accommodate the item slotting limitations at the MDV Bloomington distribution center. DeCA has been forced to downsize the current FDS dry item assortment for 11 stores supported by MDV Bloomington in order to reach the 16,000 dry slot capacity at the Bloomington facility.

DeCA has established the current dry item assortment for MDV Bloomington using a series of sku productivity and sales-based filter applications as well as critical insights from the stores and zones impacted. Any items currently housed at the MDV Bloomington facility that are not included in the DeCA item assortment will be deallocated for the stores supported by MDV Bloomington. There will be no reclama process.

Moving forward, the DeCA item assortment supported by MDV Bloomington will be tightly controlled and very closely monitored and maintained by Thomas Burkett, the designated DeCA POC/Program Manager, who will be responsible for coordinating with category managers and updating the assortment on a sku-by-sku basis with any/all adds and/or deletions. Updates regarding adds/deletions to the MDV Bloomington item assortment will be provided once approved by the Sales Directorate.
