NOTICE TO THE TRADE – DeCA NOTICE 22-76

SUBJECT: Extending Store Opening Days and Hours

The purpose of this notice is to inform industry of an initiative to extend Commissary open days and hours to better meet patron needs. Each of the stores listed below will either go from 6-day to 7-day operation or from 5-day to 6-day operation. Another 44 stores are expanding their hours of operation. We are accomplishing this inside current DeCA resource boundaries primarily by leveraging Patron Preferred Self-Checkout lanes. Please take this into consideration as you plan your product supply forecasting and in-store support plans.
